#### Description

A BY-LAW OF THE Municipal Corporation of the Hamlet of Kugluktuk in the Nunavut Territory to appoint a By-Law Officer, pursuant to the provisions of the Hamlets Act, R.S.N.W.T., 1988, c.H-1. S.171.

#### By-Law

The Hamlet of Kugluktuk desires to enforce the Bylaws of the Hamlet;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF KUGLUKTUK, at a duly assembled meeting enacts as follows:

- 1. Harold Anablak is hereby appointed as a By-law Officer of the Hamlet of Kugluktuk with authority to issue written or spoken orders to ensure compliance with the By-laws of the Hamlet.
- The duties and powers of the By-law Officer shall be described in Schedule A attached to and forming part of this By-law.
- 3. This Bylaw will come into effect immediately following third and final reading.

#### "SCHEDULE A"

### **APPOINT BY-LAW OFFICER**

Under the direction of the Senior Administrative Officer, the duties and powers of the By-law Officer shall be as follows.

a)	Encourage and ensure due observance of the provisions of the By-laws of the Hamlet;
b)	Assist in the administration of the provisions of the By-laws of the Hamlet;
c)	Conduct patrols, investigations and enquiries of the Hamlet with respect to the Hamlet By- laws;
d)	Complete daily shift reports;
e)	Report to Council as required;
f)	Prepare monthly summary reports;
g)	Perform sch duties as may from time to time be designated by the Senior Administrative Officer;
h)	Represent the Hamlet in the prosecution of any person charged with contravening a Hamlet By-law.
